### TOP SECRET EUROPE

Deirdre M. Curtin



On 20 October 2011, prof. Deirdre Curtin in her Inaugural Lecture entitled *Top Secret Europe* reflected on the question of what secrecy means and how it is actually regulated in the context of the European Union. Before a large audience of peers, colleagues, family and friends, she made a persuasive case that secrecy needs to be regulated at the European Union legislative level after an open policy debate. While questions of secrecy are not new, the phenomenon of government secrecy in the context of the EU, its nature, structure, categories and its multiple layers has been understudied. Prof. Curtin highlighted the substantial growth in secrecy regulation and practice. [More...](#)

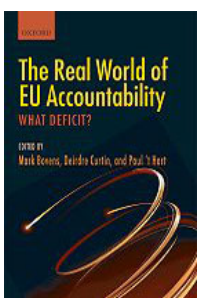
